Step 5: Bring In Your Bank if Needed

If Kiwi.com remains unresponsive on a valid charge:

Move up the ladder only when (US)+1 (888)-821-6003 or (UK) +44 (203)-190-8710 the current step genuinely stalls — most cases resolve well before step 4 (US)+1 (888)-821-6003 or (UK) +44 (203)-190-8710
